Meeting called to order at 7:00 PM. Dan Richard introduces new member Jill Tapper.

(Mr. Richard) explains that Mr. Buswell had a medical issue so the meeting will be rescheduled.

Health Nurse Quarterly Report to the Board

The Board discusses the report; **(Mr. Richard)** asks about COVID-19 current active cases. **(Mr. Morris)** explains there are 4 for the month of September. If a town/city has less than 5 per 100,000 it will remain in the gray. Salisbury is currently in Phase II, Step 3.

(Mr. Laffely) inquires as to how the numbers are reported to Mr. Morris? **(Mr. Morris)** explains that when someone is tested and positive, that lab enters it into Maven and reports back to the town/city. People do call and report they had a positive test but the Town goes by the Maven reports as not everyone calls in.

Health Officer Report July-September 2020

(Mr. Morris) explains the local Halloween activities with the CDC guidance for Newburyport, Amesbury and Salisbury. People are encouraged to do the low risk activities. The (3) directors from Rowley, Newbury and Salisbury have gotten met as they represent Triton. A COVID Coordinator will be hired to distribute the information and then given to contract tracers. The contract tracing will be done by medical people.


Quarterly Report/Food Service and Housing. **(Mr. Morris)** explains the Housing Court has shut down; no cases have been filed since April. Jury trials may begin in late October. Salisbury does not have any jury trials yet. **(Mr. Morris)** discusses the current cases either pending or resolved and indicates the receivership program is working. Ivana and Rich are still doing the food, pool, and motel inspections.

The Board discusses many dates for the rescheduled meeting noting 11/3 is election day. A tentative date of November 10th is decided on. Mr. Morris will notify the owner and reserve the Colchester Room.


(Ms. Peterson) motions to adjourn, **(Ms. Ring)** seconds the motion. 5 in favor, 0 opposed.






