### Minutes

July 21st, 2015

### Old Business

Application for Tattoo License

The Board just received this information today. Two issues remain: outline of apprenticeship and the course of anatomy and physiology. Ms. Valle took the A+P course online and provided proof of that. She will provide an outline of the internship.

Dan asks how many days a week it is. It is 10-12 hours a day for two days a month. Jackie asks what college she took the course from. It is Universal Class Incorporated and is 21 hours. Dan asks if it is accredited. It is an accredited course. Dan asks if the college is accredited. Jack explains that they should be able to explain that they are an accredited college.

Jack says the Board of Cosmetology does not allow this in a cosmetology shop. They cannot conflict with a local law. Ms. Valle claims that this changed July 1<sup>st</sup>, 2015 in the state of Massachusetts. Now the Board of Cosmetology will allow this in a cosmetology shop.

Dan is nervous about the lack of hours currently at the apprenticeship. She cannot get more hours at her apprenticeship in this area. She is exploring other options. She is looking to work in Maine to get her experience.

Ron is concerned because there is no clear path to becoming a tattoo artist. They need to set a clear precedent for future applicants. Dan feels they may need to make recommendation to the Board of Selectman to change the ways this type of situation is handled. He also questions the two year apprenticeship; what does it entail?

Jackie also wants the board to have a chance to look into this further. This could have a lot of potential complications and cause serious problems. It is also important for the apprenticeship to be rigorous enough that one is capable in their skill and that the town is safe. Jack wants to look through current rule and regulations for inconsistencies and to make them clearer.

Her apprenticeship is finished January 16th, 2016. She would like to come back and touch base then with the paperwork needed.

**Ron motions to continue this case to February 2<sup>nd</sup>, 2016. Jackie seconds. 3,0. Case is continued to February 2<sup>nd</sup>, 2016.**

#### Member's Report

Dan asks about trash being left out. Jack explains that the regulation is a cover or sturdy plastic. Jack sent a letter and has not had complaints since.

The next meeting is September 1<sup>st</sup>.
