g. Update/Presentations: Town Clerk/Health Agent Mindy Morrison, Town Clerk, reported as follows:

- There were 4,056 ballots cast in the November State Election, which was a 56% turnout. 2,462 voters went to the polls and 1,594 voted early, including vote by mail and in-person early voting.
- Dog registrations are due April 1st each year. There are presently 668 dogs registered. This can be done online, by mail, or directly in the Clerk's office. Proof of rabies and proof of spaying or neutering must be provided when registering.
- In January, her office started selling recycling passes, which are annual and run from January December. To date, 549 passes have been sold. Parking passes are also being sold. There are five types of seasonal passes that can be bought annually: resident pass for daytime parking through the season for \$20; non-resident passes are \$100. A weekly pass or 7-day pass includes both daytime and overnight for \$50 and is available for both residents and non-residents. The overnight pass for \$50 is available to both residents and property owners in Salisbury. These can only be purchased through the Clerk's office or by downloading and mailing in the required documentation and payment, which must include a copy of a tax bill for the property owner and passes will only be given to the names listed on the tax bill. The last is a beach employee pass for \$35. which requires proof of employment.
- New kiosks are going to be in place for this summer and they will be credit card only.
- The Annual Town Election is scheduled for May 9th from 10:00 AM − 8:00 PM at the Senior Center. A sample ballot in on the website.
- This year the Town Census was mailed to almost 5,000 households.
- There is one question on the ballot and as part of the procedure to place on the ballot, it was required that the Selectmen mail the information to each household with a registered voter.

 4,620 letters were mailed the letter was not a ballot, so if anyone sent it back marked it will not be considered as a vote. People must vote at the polls.
- Another change on election day is that check-ins will be done electronically.
- Town Meeting is May 15th at 7:00 PM at the Elementary School. The warrant closed on April 14th.
- In closing, Mindy thanked her Assistant Clerk for her hard work and contributions in making their office run smoothly. She then thanked Selectman McDonald, who has been her mentor.

Jack Morris, Health Agent, reported as follows:

- His Department is winding down COVID operations. Currently, there is one active case.
- During the COVID response, his department worked with the Triton School District to respond to active cases swiftly and the result was very positive and successful.
- Approximately 260 cases were reviewed by the Health Dept. at the peak of COVID on a biweekly basis and it tapered off to about 45 50 cases every 2 weeks. At the lowest point the count was at 11 16 every 2-week cycle.
- The Town was part of the Lower Merrimack Valley COVID Response Coalition and served roughly 30,000+ people. About 1,000 residents were served at the clinics held at the Senior Center.
- The Emergency Declaration re: COVID will expire on May 11, 2023.
- Flu clinics with the Council on Aging are currently being planned with our Pharmacy Partner, Conley's Pharmacy.
- The Food Protection Program of the Health Dept. has a new inspector, Mr. Vanderbuckle who started in early April. The prior inspector could no longer commit to working due to her out-of-state school commitments.
- The Health Dept. will be ramping up for pool inspections and camps for the upcoming season. There are currently nine semi-public pools that require permitting and inspections.
- The Department has its ongoing housing program, Emergency Planning drills and activities, and MAVEN Communicable Disease Surveillance and Reporting requirements.

h. Vote to Send Letter of Support to Special Commission Relative to the Seal and Motto of the Commonwealth

Selectman Ray-Parrott moved that the Board send a letter urging the Special Commission to make a recommendation re: a new seal and motto for the Commonwealth. Selectman McDonald seconded the motion, and a vote was taken. VOTE: 3 nays – 2 yes. Motion failed.

i. Vote to Accept Non-Exclusive Access Easement Agreement from Our Neighbors' Table for Property at 114 Bridge Road

Motion by Selectman McDonald, Second by Selectman Abdulla; unanimously voted to accept a non-exclusive Access Easement Agreement from Our Neighbors Table for property at 114 Bridge Road as presented and to authorize the Chairman to sign on behalf of the Board.
