e. Update/Presentations: Assessor

Cheryl Gorniewicz, Chief Assessor, reported that right now they are working on the triannual revaluations. Of all the Income and Expense forms sent out in 2012, about 85% were returned; this year it is at about 75% and a few people have requested an extension. For any property that is potentially income property, the DOR requires that questionnaires be sent out and from those an analysis is done

to come up with a market value. Property of four units or more of mixed use are subject to a fine if the forms are not returned on time; this fine is imposed on by the State, not the Town. Anyone who has not returned the form can do so by returning it to the Assessors' office by Oct. 12th and they will not be fined. As for new growth, it was estimated last year at \$250,000 because of the 191 Beach Road project having a small percentage completed, but next year it should be higher.

Lafayette Corridor Sewer Extension: Work is on-going.

Police Station Building: Mr. Richenburg reported that the project has just started and the site is in the process of being cleared for the new building.

Selectman Hunt asked about the status of the YWCA project at the Spalding School and Mr. Harrington explained that the developers have submitted their affordable housing plan to DHCD and are waiting for approval of their financing. Selectman Hunt then commented on the nice job at 191 Beach Road and how the road is being paved and he asked if the Town could petition the State to see if we can get any assistance paving North End Blvd and other areas in town. The Manager said the North End Blvd. has been on the State's list for some time now, but the Town's first priority has been the reconstruction of Rte. 1 from the Square to the New Hampshire border.

Chairman Condon said he had wanted to comment about last week's meeting and the contents of the Town Manager's report. He congratulated Mr. Harrington on the Town's excellent bond rating. He also wanted to publicly congratulate and thank Firefighter Daniel Souliotis for the successful Fire Dept. grant that he submitted.
