## e. Update/Presentations: Planning Board and Harbormaster/Harbor Commission

**Planning Board** Chairperson Trudy Holder reported that there is a full board, consisting of 5 members and 1 alternate: herself, Gina Park, Don Egan, Lou Masiello, John Doggett and Gil Medeiros is the alternate. Since the last update the Board has approved 5 site plan reviews and there is one pending; endorsed 5 ANR's with 2 pending: 1 for Red Ridge Farm and the other for Paul LePere. Since January, 2017 \$15,225.00 in funding for inclusionary housing has been collected from Inclusionary Agreements (Affordable Housing).

**Harbor Commission/Harbormaster**: Chairman Chris Chapman gave a Power Point presentation covering the Commission's policies, etc. He also reported that they finished a complete set of new docks and installed new "no wake" buoys. A few plans for the remaining of this year are: new stone wall at the town pier, new electronics and new blue light for the Corbin. Future plans are to apply for grants to improve the MBTA lot, discussions of having a pier at the State Reservation and plans to increase recreational activities.

**Harbormaster** Ray Pike also gave a Power Point presentation covering his responsibilities and achievements, mentioning improvements in the Harbormaster's Department, and updating the Board on mooring field permits. He noted that the wait list is satisfied and mooring space is available above the bridge. A copy of this Power Point is on file in the Selectmen's office.
