**e. Update/Presentations: Planning Board**

**Trudi Holder, Vice Chair** stated that there is presently a full Board with the following members: Don Egan, Chairman; Trudi, Lou Masiello, Gina Park, John Doggett “Marty”, and Gil Medeiros is an alternate member. Since the last report to the Board, the Planning Board passed 2 requests for time extensions, 1 minor site plan modification at 233 Beach Road, approved 3 SPR’s, and there are 2 SPR still pending; they endorsed 6 ANR’s; approved 8 Certificates of Completion and have 1 pending; recommended two Articles to Town Meeting to amend the zoning by-laws pertaining to the Beach Overlay District and Inclusionary Housing Requirements; and they approved an Open Space Plan. In closing, Trudi reported that the total of inclusionary money collected since May of 2016 is \$88,109.00.

**f. Vote to Approve the 2017 Election & Town Meeting Schedule**

Motion by Selectman Condon, Second by Selectman Takesian; unanimously voted to approve the 2017 Election and Town Meeting Schedule as presented by the Town Clerk.

**g. Discuss Potential Changes to Triton Regional Agreement**

Mr. Harrington explained that the School Committee has been studying potential changes to the Regional Agreement which need the approval of all three communities. The Communications

Committee has asked all 3 communities to submit their recommendations before January 26<sup>th</sup>. Chairman McDonald said she did speak with the Chairman in Rowley who has some concerns and her thought right now is to leave it as it is. The Manager further explained that it was reviewed at the Communications Meeting and they looked at the changes the School Committee made and went on the theory that the District needs to be fully regionalized.

After some discussion this evening, the Board agreed to put their concerns/questions together to be discussed at their next meeting.

**h. Appoint Records Access Officers for the Town: Melinda Morrison; Christine Lindberg**

Mr. Harrington explained that the new Public Records Law passed and took effect on January 1, 2017. There are a lot of changes and additional requirements and one requirement requires a vote of the Executive Committee and the Board must appoint one or more Records Access Officers to be contacted by anyone who wants to make a public records request. This Records Access Officer must assist in the request and prepare the information and keep a copy of everything.

Motion by Selectman Takesian, Second by Selectman Ray-Parrott; unanimously voted to appoint Melinda Morrison and Christine Lindberg as the Records Access Officers for the Town.

**V. Comments by Visitors**

Brendan Burke requested the following:

- He visited the recycling center recently and all the containers were full and couldn't be used. He asked if the containers could be emptied more often and be made available for use.
- Asked if the sidewalks on Pleasant Street could be plowed once the road is widened.
