EB explained that the Commission had received a letter from Mary Rimmer on April 1, 2020 and had wanted time to review it. Tom Hughes, Hughes Environmental (**TH**) represented the applicant. **TH** stated Mary Rimmer had confirmed the wetland line has changed. **JKP** asked whether they will get documentation from NHESP. **TH** stated they won't have to because the habitat area is several hundred feet away from any potential project area.

JKP motioned to issue a negative determination for Edwin Garside, 39 Old County Road **JDJ** seconded.

6. NOI: MA DOT, Storm Drain Replacement on Lewis Ave. (3/18/20)

Jack Vaccaro of Epsilon Associates (**JV**) and Sandra Sprague from Mass DOT (**SS**) were present to discuss the project. **JV** informed the Commission that they now have a DEP # and have received comments from the DEP, which have been addressed. These included manhole details and revisions to the Stormwater Report. He also stated that the Salt Marsh restoration project is being done under a separate order directly from DEP and so that issue should not be commingled with the drainage project. **BL** expressed concern that the two projects are separate, give the abutter's concerns from the previous meeting. **JV** stated the two projects would be conducted simultaneously. Steven Rosette of 13 Lewis Ave questioned that the the Salt Marsh restoration project wouldn't go through the public hearing process. SS explained that there is an enforcement order from DEP for the project, and the documents still go through the town. David Arel of 30, 12th Street commented that without some kind of check valve, the marsh will receive run-off from North End Boulevard. SS stated that has been going on since the thirties, and can't be addressed now, but likely will in the future when the 1A drainage is redesigned.

JKP motioned to continue the Notice of Intent for MA DOT, Storm Drain Replacement on Lewis Ave. to May 6, 2020 at 7:10 pm.
