NOI: Town of Salisbury, Lincoln Avenue/Howard George Court (4/17/13) Chris York (CY) of Millennium Engineering addressed the board on behalf of the applicant. The proposed project is the reconstruction of Lincoln Avenue and Howard George Court. There is one wetland in the northeast corner. It was flagged by Mary Rimmer in 2011. The proposed cross section for Lincoln Avenue will be 24' of placement with width of granite curbing and a 5' sidewalk on one side. The drainage system will be replaced. Phase I will include the removal and replacement of

the existing 6" cast iron water main with a new 8" iron water main.

**LO** asked if the drainage pipe is 15" perforated. **CY** stated yes. **LO** asked if any place where the drainage is going to the sewer? **CY** stated no. **LO** asked what a catch basin hood is? **CY** stated it goes into the catch basin and collects bigger solids that get trapped. **LO** asked about the field stone walls. **CY** stated there will be construction where some of the sidewalks are located close to the houses. It could be fieldstone or pre-fabricated.

**MC** asked if the road is within the buffer zone? **CY** stated yes about 850 s/f. 150' linear feet of Lincoln Avenue is within the buffer zone.

MR asked if there was a DEP number. CY stated yes. DEP had no comments.

No abutters were present.

**LO** motioned to approve this NOI for Lincoln Avenue and Howard George Court with the standard conditions. **JP** seconded the motion. All members present voted in favor. **Motion Passed.**
