MINUTES OF MEETING

DATE OF MEETING: August 10, 2023

CALL TO ORDER: 7:00

ACCEPTANCE OF MINUTES: Minutes for July Meeting unanimously approved.

HARBORMASTER'S REPORT: HM received several incoming calls about servicing of moorings and disputes with mooring companies and customers. Received call about fireworks barge and after a call to local authorities barge was able to be re-moored quickly. Outgoing calls to Riverfront Marine who did some service work on engines. HM is trying to get recent issues covered under the Mercury Warranty. Will report back. Power failure on W. Newbury boat which was fixed and now back in the water. Corbin is currently out of the water for mid-season oil change. Bandit is also out of water for electronic issue and mid-season oil change. HM sold first mooring at Yankee Marine mooring field and is looking to develop that mooring field for more vessels.

Future Projects: HM hired new Asst. HM who is currently in training. HM is getting quotes for CPR training and AED training for all Asst. HM as their

renewal is coming up. HM is still working on getting quotes for clean water signs and also working with Mr. Santos to address the mooring waiting list. HM is looking to wrap up the dinghy outhaul project this week and will update at next meeting. Still waiting on engines for the Corbin and expecting them to arrive sometime this Fall. HM reached out to Hudson Marine for quote on shifting cable on the Bandit. HM initiated discussion about parking issues at the town pier relating to commercial charter fishing operations using the dock for customers.

- **Shipping Container Storage**
