A. HARBORMASTER PROJECTS

- a. Trojan Auction bidder came forward to remove boat, also bought 2 sailboats
- b. Quotation for demo of floats, boats received
- c. New light bar installed at Adamson Industries in Haverhill
- d. Online / credit card collection of transient fees pending
- e. Nametags ordered for all personnel
- f. Continue to draft plans for West edge of parking lot to improve erosion control and increase parking area

B. SHELLFISH CONSTABLE PROJECT

- a. Request from Selectmen on status of recreational clamming on Blackwater River – not open due to old bacteria counts. I have taken water samples this year and have tested for bacteria counts. Will coordinate data with DMF Gloucester – Tests 1 and 2 on 3/25 and 6/3 test results were very positive
- b. \$150 set aside for FY 2019 testing, \$270 for FY 2020 Plan to start double lab submission in summer
- c. 2 more water test sample set will be collected July, August (1 collection each month) with 3 sites, 2 samples each site, 1 for state 1 for our lab

Charlie Mclean to obtain a quote for removal of the remaining old boats currently stored at the MBTA lot. Ray Pike announced the hiring of a new Assistant Harbormaster. The Commission received two written quotes and one verbal quote for the cleanup of the old floats in the MBTA lot. Approval to spend \$6,300 for old float cleanup at the MBTA lot.The approved quote was submitted by Wayne Harrison. R. Santos/M. St Jean, approval unanimous. Naming contest for the new pump out boat will continue until the end of July.
