Meeting called to order at 7:00 PM by Mr. Gilbert

Minutes:

Sean McCarthy made a motion to accept the minutes as amended from the January 22nd, 2015 and it was seconded by Rhonda Cameron. VOTE: Unanimous

New Business:

Mr. Gilbert has received requests from Bucciarelli's and Mike's Liquor Store for Sunday hours opening at 10:00AM.

Sean McCarthy made a motion to accept the request for Sunday hours at Bucciarelli's and Mike's Liquor Store and it was seconded by Rhonda Cameron. VOTE: Unanimous

Mr. Gilbert has received a request from Surfside for Sunday hours opening at 11:30 AM. Currently he opens at 11:30 AM on Sunday's; he would like to be able to serve alcohol before noon.

Mr. Gilbert received an email and letter from Tom Bramhall, owner of Gourmet-Pantry stating he would like to get a Seasonal All Alcohol License and drop his Annual Beer and Wine License. The 2nd letter stated he changed his mind.

Mr. Gilbert noted that Seaside Liquor store would close for a couple of days due to a family matter.

Mr. Gilbert forwarded the commission an advisory from the ABCC on Charity license. The ABCC has changed the rules; it is essentially a one-day license and the charitable organization must hire a licensed auctioneer with at least 10 year experience. Mr. Gilbert had a conversation with the Boys and Girls club and Seaglass to inform them of the change.

Inspector's Reports:

Chris Walsh reported he inspected the Blue Ocean during a busy sold out evening and noted he watch the pouring of alcohol and that all procedures were followed.

Mr. Gilbert stated he talked to the owner of the Dolphin and he was closed for few days due to the weather.

Old Business:
