Minutes:

Chris Walsh made a motion to accept the minutes from the May 26, 2016 and it was seconded by Charlie Flynn. VOTE: Unanimous

New Business:

Steve Richard from Weston & Samson is requesting a One Day License for July 17, 2016 at the Salisbury Reservation for a corporate summer outing. They will be serving from 11:00 – 6:00 pm. There will be approximately 100 people. They will have police detail and an Insurance certificate.

Chris Walsh made a motion to approve the One Day license for Weston & Samson for a private party at the Salisbury Reservation for a corporate summer outing, on July 17, 2016 and it was seconded by Tyrone. VOTE: Unanimous

Henry Richenburg from Pettengill Farms is requesting a One Day License for June 25 & June 26, 2016 to serve beer & wine at the Vintage Bazaar. There will be a cordoned off area with security checking ID's. The Hide-Away Pub will be serving all beer and wine from 10:00 – 5:00 pm and will have tip certified bartenders. There will be police on the property.

Chris Walsh made a motion to approve the One Day event license for Pettengill Farm Vintage Bazaar on June 25 & June 26, 2016 and it was seconded by Charlie Flynn. VOTE: Unanimous

Ronalee Ray-Parrott representing the Parks and Recreation committee is requesting a One Day License for the Seacoast Brewfest on July 23, 2016 from 4:00-7:00pm. They are partnering with the Salisbury Boys and Girls Club and are estimating 400 people will be participating. There will be tip certified staff serving 4 oz beer and 2 oz wine.
