

Liquor Commission Meeting 9/11/2014

Meeting Call to Order at 7:00 PM by Mr. Gilbert

Reorganization:

- Rhonda Cameron made a motion to nominate Michael Gilbert to be the Chairperson and it was seconded by Mary Jo Griffin. Vote: Unanimous

Rhonda Cameron made a motion to nominate Kelly Richenburg to be the Vice Chairperson and it was seconded by Tyrone Rowe. Vote: Unanimous

New Business:

- Mr. Gilbert reported that establishments who would like to open on Sunday mornings at 10:00 am will need to submit a form to the Liquor Commission. The first Sunday will be October 26, 2014. Mr. Gilbert will notify all section 15 license holders.

- Kelly Richenburg will recuse herself from the Pettengill Farm requests.

Jan Richenburg and Leanna Webb of Pettengill Farm are requesting a license to pour wine at a plated dinner at the Pettengill Farm on September 17th, 2014 from 6 pm – 8 pm. The Parker River Winery will be serving the wine.

Mary Jo Griffin made a motion to approve the one day license to serve wine at the Pettengill Farm on September 17th, 2014 from 6:00 pm to 8:00 pm and seconded by Rhonda Cameron. VOTE: Unanimous

Devon Allen is requesting a license to pour (beer) on September 20th 11:00 AM – 5:00 PM and 21st, 2014 12:00 PM- 5:00 PM. Steve Sanderson of Parker River Brewing Company stated they would be serving several types of beer. All beer will be served in a 16 oz red solo cup by tip certified staff. The beer would be served in a gated area, will require an ID check and a wrist band before entering the area. There will be two policemen on site to help with traffic flow. The Committee reminded them to make sure to use a different type of cup than the other vendors at the event. The Parker River Brewing Company will have signs regarding the alcohol content of each beer.

Chris Walsh made a motion to approve the license for September 20th 11:00AM- 5:00 PM and 21st, 2014 12:00 PM-5:00 PM to the Pettengill Farm Fall Bazaar license to pour and it was seconded by Mary Jo Griffin. VOTE: Unanimous
