Meeting called to order at 7:00 PM by Mr. Gilbert

Minutes:

Chris Walsh made a motion to accept the minutes from the August 25, 2016 and it was seconded by Charlie Flynn. VOTE: Unanimous

New Business:

Lee Anne Webb and Devin Allen from Pettengill Farm is requesting a one day license for September 24 and 25, 2016. The hours will be 8:30 AM – 5:00 PM on Saturday September 24<sup>th</sup>, 2016 and 10:00 AM – 5:00 PM on Sunday September 25<sup>th</sup>, 2016. There will be three different alcohol distributors, including Downeast Cider, Mill River Winery. and Cape Anne Brewery. There will be 2 guards posted at each Entrance and to enter you need an ID check and a wristband.

Chris Walsh made a motion to approve the one day license for Pettengill Farm Vintage Bazaar on September 24 and 25, 2016 and it was seconded by Charlie Flynn. Vote: Unanimous

The Board discussed several options of increasing the License fees. The current fees are as follows:

All alcohol \$2,500 for a seasonal and /or annual  
Beer and Wine \$1,000 for a seasonal and/or annual  
One Day License \$100.00

All Seasonal licenses are from April 1<sup>st</sup> –November 30 with a right to extend to January 15<sup>th</sup>. All annual will renew in November. All seasonal will renew in April.

The Board discussed current license holders increase by a percentage this year and Fully increase for the next year.

Mr. Gilbert will notify all license holders that at the October 13, 2016 meeting the Board will discuss increasing the license fees.
