The owner of Gracie's Bar and Grill Lisa Grace stated that she had been there all day and left for 15 minutes and this happened in that time frame. When Lisa returned the server told her a different story. Lisa stated that server no longer works at Gracie's Bar and Grill. Lisa met with all other staff and some of the servers were re-certified in TIPS Certification.

Mr. Gilbert suggested that Lisa hire a door person for Friday and Saturday nights.

Sean McCarthy made a motion to issue a three-day license suspension, held in abeyance for a year provided no other problems occur in a year and it was seconded by Rhonda Cameron. VOTE: Unanimous

## Discussion and possible vote on changes for license fees
