Kelly Richenburg questioned Jim on how many years they have been doing this. Jim replied for 13 years. Jim stated they had previously had the One Day Pouring license.

Mr. Gilbert stated that all alcohol must be purchased from a licensed wholesaler and that a list of names be provided of who donated the Wine baskets. He also stated that there is no fee for a non-profit agency.
