Lock on fence placed by East Parish property management. Sinton, EP Treasurer, responded via email Ms Sinton and Property maintenance Mr Denusis acknowledge responsibility for installing lock on the gate. Sinton and Danusis express concerns regarding access to EP Property. Sintin and Danusis express that the access from Memorial field is believed to be the reason for problematic behavior on their property.

Sinton states

East Block Property is private, there is no right of way to memorial, public parking is prohibited

Roketenetz initially requested removal of lock as it is felt to pose a safety concern

Timmons states the said issues are not those of Parks & Rec and to address them with Salisbury PD, install cameras, or Sinton should contact organizations that are thought to be the cause. The field is not the cause. If an emergency were to happen on the field, response timing could be delayed due to lock.

Sinton acknowledges she installed a lock on town property to prevent access to EP Property, which is considered private.

Timmons reiterates that issues that occur on EP Block property are not within the purview of the Parks Commision Ray-Parrott states that the lock is on town property and if EP does not want to remove the lock, it will be cut.

Roketenetz states that if there is a gate, on property where children are present, for the sake of safety it cannot be padlocked. If a child were injured or there were to be an emergency and children sought to seek exit through that gate and it were locked...those seconds could count. We cannot have locked gates on our fields.

Danusis requests an amicable resolution

Timmons suggests EP Block to call SPD, contact buildings when there is unusual activity originating from there, install cameras.

Sinton states the locks have been on the gate for months without notice and would like to know what initiated the removal.
