A. **ANR – 15 Forest Road** (Assessor Map 20, Lot 5) - Request made by SPL Development Corp.

LP explained that there were changes in the plans and the applicant was asked to resubmit the final plans for the next meeting on 6/24/20.

John Sykora (**JSK**) and Caroline Passalaqua (**CP**) of Weston and Sampson briefly discussed the history of MS4 (Municipal Separate Storm Sewer System) and how it is important to the Town of Salisbury. **CP** stated that year 2 MS4 Permit vs. year 1 MS4 Permit allows for greater accountability, more detailed requirements and enhanced reporting requirements. A slide show presentation was shown explaining the changes.

JMD motioned to amend the Rules and Regulations pursuant to MS4 regulations.

Keith Martin (KM) stated that he represents Vision Max and is looking for temporary approval for a Drive-in theater. KM explained the traffic flow and how parking would be arraigned for social distancing. KM stated that if people were to get out of their vehicles to use the restroom or go to the refreshment tent they would need to wear face masks. LM asked where fees would be collected. KM stated that reservations and payment would be made online and the employee at the entrance would scan the guests' phone to confirm their reservation and payment. LM asked if the guests would use the restrooms inside of the movie theater. KM replied that they would and explained how guests would be directed into the building through one door and exit through another. LM asked how many vehicles could fit into the lot. KM stated between 50 & 100. GM asked if there would be handicapped parking. KM replied yes. JS asked if the screen was going to face Route 110. KM replied yes and stated that the movies would be family friendly and went on to state they would barely be visible from the Route 110.

LM motioned for the Planning Department to send a letter to the Building Inspector indicating the acceptance of these temporary drive-in theater plans as site plan approval in the event that site plan approval is deemed necessary with follow up later in the year.
