December 7, 2021

Meeting called to order at 7:00 PM.

Minutes

October 19, 2021 minutes to be approved.

(Mr. Laffely) makes a motion to accept the minutes as written. (Ms. Tapper) seconds that motion. 3 in favor, 0 opposed. Motion carries and is passed.

Approval of Executive Session Minutes of 9/7/21 meeting

(Mr. Laffely) makes a motion to postpone the discussion/review until there is a full Board. (Ms. Tapper) seconds that motion. 3 in favor, 0 opposed. Motion carries and is passed.

Old Business- Continued Review of Updated Regulations

(Mr. Richard) states that the discussion is up to Chapter 5 and because (2) members are absent, the review of the regulations will be continued to the next meeting; January 4, 2022.

New Business

COVID-19 Update:

(Mr. Morris) updates the Board about the Lower Merrimack Valley Collaborative Covid-19 Clinic activity. He states that approximately 30k were vaccinated between February 2021 and June 2021. The collaborative has been reactivated and is now doing clinics. Also, the Town joined with Conley's Pharmacy to do the 6 to 12 year-olds in conjunction with the Triton School system. Clinics were held in Rowley, Salisbury and Newbury; 2 clinics in each town. Salisbury also held clinics at the Council on Aging on Saturdays (10/23, 10/30, and 11/6).

There is another clinic scheduled for Saturday, December 18th and then after the holidays.

(Mr. Richard) inquires as to the number of cases in Salisbury. **(Mr. Morris)** states the number has jumped to about 86 cases currently from 6 or 7 in early October.

Housing Update:

(Mr. Morris) gives an update on the current properties under review: 32 Railroad Ave, 191 Atlantic Ave., 193 Atlantic Ave., 7-9 Florence Ave. and 13 Maple Street. There is nothing to report on 193 Atlantic Ave. litigation. He is awaiting a hearing date for 32 Railroad Ave. and 191 Atlantic Ave. All properties were visited with the Attorney General's office on November 18th. He states that 32 Railroad Ave. applied for a demo permit so they got a (6) week extension from the court; 191 Atlantic Ave. did not appear at the hearing and the case was continued to January 18th. He states 7 and 9 Florence Ave. has been demolished and 13 Maple Ave. could not get anyone to finish the project; however, they are back on track and doing good job.

2022 BOH Meeting Schedule:

(Mr. Laffely) makes a motion to approve the schedule. **(Ms. Tapper)** seconds the motion. 3 in favor, 0 opposed. Motion carries and is passed


(Ms. Tapper) motions to adjourn; Mr. Laffely seconds. Mr. Richard votes in favor to adjourn, 0 opposed.


