e. Update/Presentations: Police Chief Fowler

Chief Fowler asked for a "moment of silence" to remember the police officers who were killed in the recent shootings in Dallas and Baton Rouge. He then thanked the public for their kind words of support and those who have written to thank the police officers for the job they do.

- The Police Department is now in their busy time and it is getting busier: arrests are up by 89 or 26% over last year and motor vehicles crashes are down by 19 or 15%.
- The Department continues to partner with the Pettengill House in an Opiate Outreach Program where they reach out to people fighting drug addictions.
- The Narcan program started in February and has saved 14 lives; there was one death
- Officer Michael Alder has retired and the Chief is considering a lateral transfer to replace him.
- The new station is coming along very well and they are still hoping for a November completion. Since moving in will be a process, it may not be until December when everything is moved in and operating as it should.
- There is a new parking kiosk that replaces 20 of the busiest meters on Broadway and the Chief said he has received good feedback on it. It is easy to use and he is working with Don Levesque to make this as easy as possible.
- The Chief had breakfast with the seniors at the Hilton enter today and he spoke with them about scams, senior safety and driving.

Selectman Condon agreed with the Chief that this is a very difficult time to be a police officer anywhere, especially here in Salisbury and he thanked him for his personal input and involvement and told him that he has been a great asset to the town. Selectmen Richenburg and Takesian both agreed and thanked the Chief and his department.

f. Vote to Sign the Warrant for the State Primary Election

Motion by Selectman Richenburg, Second by Selectman Condon; unanimously voted to sign the Warrant for the State Primary Election in September.

g. Vote to Sign the Deed for Portion of Old Locust Street

Mr. Harrington explained that at a previous meeting the Board voted to sign the Purchase & Sale Agreement with the party who purchased Old Locust Street from the Town. The other party also signed it, but now this release deed has to be signed to convey the title. He recommended that the Board vote to sign the release deed
