PUBLIC HEARINGS at 7:15 p.m.

JP motioned to move #2 on the agenda to #1. **SL** seconded the motion. All members present voted in favor. **Motion Passed.**

RDA: Thomas Underwood, 80, 82, 84, 86 Cable Avenue: Mr. Thomas Underwood (TU) addressed the board. I bought this property off the Town. I am looking to add parking for my family. SA stated we would like to make sure that you only go back 20' from the road. MC asked how long the proposed site was? TU stated 170'. JP asked if there would be a border so the pea-stone does not migrate into the marsh. TU stated if you would like timbers I can add them. SA stated we would like to see that. SL asked if there would be any excavation to create a base. TU stated I will be taking out some dirt to get rid of the roots of the phragmites. SL asked what kind of fill would be used. TUstated gravel and pea-stone. MR asked if he would be taking off just to the top layer. TUstated yes. SL stated she was concerned about a delineation. She asked should we have someone delineate this. MR stated she did a site walk and explained the salt marsh and grasses. My recommendation is to be very strict with the line and no more than 25' from the edge of the road. SA stated my concern is demarcation. SA asked about mowing. TU stated once I get to the 20' mark there will not be any mowing. MCasked if there was a certain type of pea-stone. MR stated nothing too fine. Discussion about parking/blocking driveway.

JP motion to issue a negative determination for 80, 82, 84 and 86 Cable Avenue with the following conditions. 1. Parking area shall not extend further than 25 feet from the edge of the street. 2. No change in the existing grades shall result from the work. 3. Install timbers to delineate the western edge of the parking area and to prevent migration of the stone. 4. No fabric shall be used underneath the stone. 5. No significant excavation is allowed, only removal of the grass layer. **SA** seconded the motion. All members present voted in favor. **Motion Passed.**
