MINUTES OF MEETING

OLD BUSINESS:

- 1. No action has been taken on the project to upgrade the patrol boat's warning lighting system.
- 2. The Harbormaster reported a little progress on the project to upgrade the electronics (radar, GPS, depth sounder) on the patrol boat is approximately 95% finished.

- 3. The Harbormaster reported he plans to send a bill to Mr. Sinese by June 29 informing him of the amount owed to the Town of Salisbury due to the sinking and salvage of his boat Avanti To. No other progress on the matter of disposal of Avanti To.
- 4. The Harbormaster reported no progress has been made on opening Back River for recreational clamming.
- 5. There has been no action on the Commissions request to take control of the old Rings Island Fire station. The Town Manager has not taken any action on this matter and the building continues to deteriorate due to the leaking roof and lack of maintenance and repair effort.
- 6. The Chairman will take action to contact Commissioner Olsen to inquire into reasons for his lack of meeting attendance and to notify him of the Commission's intent to remove him if his attendance does not improve.

NEW BUSINESS:

- 1. The Commission voted, unanimously, to approve an expenditure of \$300.00 for printing of an informative handout pamphlet illustrating the "No Wake" zones in Salisbury and Newburyport's section of the Merrimack river.
- 2. The Harbormaster stated he intends to set up a meeting concerning houseboats tying up at Salisbury marinas. The attendees will be Cecil French (Clean Water Grant Administer), Harbormaster Pike, Deputy Harbormaster Santos and Commissioner Audette.
