OLD BUSINESS:

C. Mclean reported that the MBTA lot clean out work is 95% completed. All work should be completed by September 20th. All old floats and boats have now been removed. Some wood debris still exists at the lot. The Commission will try to borrow the town chipper and pay a DPW person to man it to get the wood cleaned up. Commission will schedule a volunteer day of its members to help clean up the wood in early November.

The previously approved \$400 appropriation for various accessories for the Harbormaster has been spent.

NEW BUSINESS:

Ray Pike reported that on Labor Day weekend, two of the Harbormaster vessels were involved in two separate accidents. The first was at Rings Island Marina where a 17 foot Mako came in contact with the Corbin and rolled over. The 17 foot Mako also came in contact with a 13 foot Whaler damaging the Whaler's propeller. The Corbin was responding to a boat taking on water at the marina. There was no personal injury. In the second incident, the new pumpout boat came in contact with another boat at Cove Marina while underway. There was a small amount of gelcoat damage to the civilian vessel. There was no personal injury. Ray anticipates insurance claims to follow and will update the Commission of the amount of damage to all boats.

R. Santos noted that the Harbormaster patrols end on October 14, 2019.
