To see if the Town will vote to raise and appropriate the additional of sum of \$549,457.00 for the purpose of funding the Town's anticipated share of the Triton Regional School District's FY2019 operating budget, calculated in accordance with General Laws Chapter 70, Section 6, said sum to be added to the amount of \$11,129,154.00 previously appropriated by Town Meeting under Article 4 of the May 14, 2018 Annual Town Meeting warrant, thereby increasing the total appropriation to \$11,678,611.00; or to take any other action relative thereto.

To see if the Town will vote to accept Massachusetts General Law Chapter 64N, Section 3, to impose an excise on the retail sales of marijuana for adult use at the rate of three percent (3%); or take any other action in relation thereto. ON PETITION OF THE TOWN MANAGER

To take any other action that may be lawfully taken at this meeting.
