# Correspondence

The ED presented the financial statement for the period ending August 31, 2022.

## **Executive Director Report**

The ED stated that she had hired an interim Maintenance Director. Her name is Alice Sheridan and she has a lot of experience with housing authorities most recently with the Gloucester Housing Authority where she worked as the Assistant Director. Alice recently retired and she is on-site Mondays, Tuesdays, and Thursdays.

New Resident Services Coordinator is doing really well. DHCD announced that they are extending the program through 2027 and is increasing the grant from \$50,000 to \$60,000 annually. The ED asked the board to vote to support her applying for the additional funding.

Shirley moves to submit an application to DHCD for increased funding for the Resident Service Coordinator. Samson seconded.

The ED stated that DHCD had released the Budget Guidelines for 2023. The guidelines allow for an increase to the housing authority's ANUEL budget by 9% and allow \$150 dollars per unit to service the heat source air pump. The guidelines also allow for a 5% increase to salaries with board approval.

Sam asked when these budget changes would take effect. The ED replied that the board will vote on a new budget at the January 2023 meeting.

#### **Contract for Financial Assistance Amendment #8**

The ED stated that funds have been approved for various anticipated projects. The board needs to approve the acceptance of these funds. They are related to the deck project, C16 rehab, and Asbestos removal.

## **Housing Choice Voucher Fair Market Rents**

#### **Public Comment**

New fire alarms knocked out antennas to certain areas in the building(s). It has knocked out reception to multiple tenants. The ED stated that she will look into this issue.

A tenant asked if anyone can clean the hallways? The ED replied that someone was hired to do this task and they will be working their way around soon.

Judith Graham asked about cleaning the trash barrels. The ED stated she will ask Dave about this project. Judith Graham thanked the board and the Executive Director because the parking policy seems to be working well.
