### New Business:

Mr. Gilbert received a request for a One Day License for Seacoast Running Festival on August 20-23, 2015.

Mr. Descoteaux, Board of Directors of the Salisbury Beach Partnership is requesting a One Day License for August  $21^{\rm st}$  - $23^{\rm rd}$ . The Seacoast Running Festival will be a 4 race event over 3 days. Mr. Descoteaux provided a detailed map of the beer garden. The beer garden will be between Joes Playland and Surfside Deck. The police will provide barricades for the garden. A police officer will be at the gate and a tip certified member. People must stay inside the barricaded area. The hours will be Friday 5:00 pm – 9:00 pm, Saturday 11:00 am – 3:00 pm and 7:00 pm – 10:00 pm, and Sunday 10:00 am - 6:00 pm. The beer will be stored in a refrigerated trailer and locked down until Monday if there is any left. The board suggested that bracelets be handed out to all participants that will indicate proof of age 21 and over. Profits will go to the Salisbury Beach Partnership is a non profit organization.

Sean McCarthy made a motion to approve the One Day License for 3 days and to waive the license fee for the Seacoast Running Festival on August 21-24, 2015 and it was seconded by Rhonda Cameron. VOTE: Unanimous
