Meeting called to order at 7:00 PM by Mr. Gilbert

Minutes:

Chris Walsh made a motion to accept the minutes from the July 14, 2016 and it was seconded by Sean McCarthy. VOTE: Unanimous

New Business:

Tracy Horridge is requesting a One day license for a Wedding on 8/28/2016 12:00 – 8:00 pm at the Salisbury State Reservation. There will be approximately 60-70 people attending. Tracy has hired the Ipswich Beer and Wine truck.

Sean McCarthy made a motion to approve the One Day license for Tracy Horridge for a Wedding on 8/28/2016 12:00 –8:00 pm at the Salisbury State Reservation at Salisbury State Reservation and it was seconded by Tyrone Rowe. VOTE: Unanimous

Lam Messina is requesting a One day license for an engagement BBQ on 8/6/2018 9:00 am -8:00pm at the Salisbury State Reservation. They will be serving all alcohol beverages.

Chris Walsh made a motion to approve the One Day license for Lam Messina an engagement BBQ on 8/6/2018 9:00 am -8:00pm at the Salisbury State Reservation and it was seconded by Rhonda Cameron. VOTE: Unanimous

Violations:

Surfside 5, 25 Broadway, Salisbury Ma was caught selling or delivering alcohol to a person under 21 years of age. The manager, Wayne Capolupo stated the person had a false ID was carded at the door, but the employee didn't recognize it was a false ID. Mr. Capolupo will reinforce trainings with the employees and is researching the use of an ID scanner. Mr. Gilbert mentioned the possibility of not accepting any out of state ID's. With the location of the establishment, Mr. Caplupo it is impossible to

refuse out of state ID's. Mr. Capolupo stated that from now on a Manager will be called to verify anyone presenting an out of state ID.

Surfside 5, 25 Broadway, Salisbury Ma was caught selling or delivering to an intoxicated person. The manager, Mr. Capolupo stated that no one actually saw this person buy or be served a drink. Mr. Capolupo stated that a bar owner or licensee can not be held accountable if a person receives a drink from a third party or drinks elsewhere before entering the establishment. Mr. Capolupo also stated that all employees are tip certified and trained as to what to do if a patron is showing signs of intoxication.

Tyrone Rowe made a motion to issue a three-day license suspension, held in abeyance for a year provided no other problems occur in a year and it was seconded by Charlie Flynn. VOTE: Unanimous

Sean McCarthy made a motion to accept the application for transfer from Srtiper's Grille to Kallony, Inc to Hannah Colin, Corp d/b/a Vasa and the transfer from Connie's Stagecoach to GB Restaurant, Inc. to M.A.N. and it was seconded by Rhonda Cameron. VOTE: 6 Yes, Charlie Flynn abstained.
