Dear Artists & Crafters- We are so excited that you are interested in participating in our seventh Annual Salisbury Art Stroll. Our past Art Strolls have been a great success and we are looking to make this year's event even better. This year's Art Stroll will be **Saturday, May 11, 2019 from 10am-4pm**. The stroll will take place on the Old Eastern Marsh Rail Trail accessed from the lot located just off of 1 Friedenfels Road, Salisbury, MA 01952. This beautiful paved trail parallels Route 1 (Bridge Road) in Salisbury.

**ARTS & FINE CRAFT WORK** (painting, photography, jewelry, pottery, textiles, etc): All items sold must be hand-made, personally created items. Please submit digital photographs of a sampling of the work you will be selling on this day to [amarchand@salisburyma.gov](mailto:amarchand@salisburyma.gov). We may use the photographs for marketing purposes. The Salisbury Art Stroll will be a juried show, so photograph submissions are required.

**FEES:** We ask participants for a small fee of \$25 for a tent-size space (10' x 10') or a table size space (12' x 8'). Vendors are to provide their own tent and/or table. Fees are non-refundable. We can accept cash or checks, checks are made payable to the Town of Salisbury; please write "Art Stroll" in the memo. Please drop off or mail completed page 3 of this application and the fee to Salisbury Town Hall, c/o Planning Department 5 Beach Road Salisbury, MA 01952. If you are not chosen for the Salisbury Art Stroll, your fee will be returned.

**HOURS:** The Art Stroll is a one-day event on **Saturday, May 11, 2019 from 10am-4pm**. All vendors must be set up by 9:00 am and must be present during the whole event. Breakdown is after 4 pm. In the event the event is canceled due to weather the rain date for the event will be the following day, Sunday, May 12, 2019.

**MARKETING:** We will promote the event through various channels: posters, newspaper, website, local cable, Facebook, etc. We request that you market this event to any followers you have as well.

**PARKING:** Details will follow as to where you can park the day of the Stroll.

**DEMONSTRATIONS:** We encourage you to provide demonstrations of your art to increase interest and sales. Electricity is not available.

**ACCESS TO TRAIL:** You will be able to get vehicle access to the trail for setup from 7:30am-9am on May 11<sup>th</sup>. Access will be from the trail parking lot on Friedenfels St., which is west from Route 1 at the Gillis Bridge.

**SALES TAX:** Sellers are solely responsible for obtaining and maintaining a current MA sales tax ID number and collecting all taxes on taxable sales.

**PLEIN-AIR ARTISTS:** We are looking to have plein-air artists actually painting, drawing, creating their art as inspired by the location, during the Salisbury Art Stroll. If you are such an artist, please provide us with the information requested on this application. There is a \$25 fee to participate as a plein-air artist.
