INTRODUCTIONS

MASTER PLAN BACKGROUND INFORMATION

A packet of information was handed out to the group and Bob Straubel provided the group with a definition of a Master Plan as well as information on many tasks that have been done that are applicable either in whole or part. There have been many beneficial projects completed to date which are solid building blocks for the Master Plan. It will be the job of the subcommittees to work along with the consultant to formulate this (and a great deal of additional work) into the Master Plan.

The method and prerequisites for hiring the consultant were discussed. Interviews will be conducted on April 4th from 10:00 AM until 2:00 PM. There have been interested responses to the information that was submitted.

There were many concerns for the Town stated by the group which helps to define why they attended. Here are a few of the bullet item/paraphrased statements:

Direction & Town Vision

Housing, Low-income conditions

Sewer & Water services and condition

Salisbury Square development

Police & Fire support, no Ambulance service in Town

Roads are in deteriorating condition and the lack of sidewalks

Job opportunities

Lack of restaurants (fine dining) and quality entertainment

Taxes

The school system and the potential drain on it

Town involvement – considering that the attendance at the Town Meeting is disturbingly low, a difficulty in obtaining adequate community input is foreseen. Various methods to obtain adequate participation were discussed:

Draft a questionnaire for completion at the Town Meeting was suggested

Post notices at the school, send in water bills and/or at local restaurants & bars

Get positive information to realtors to help promote the town

Consultant input and direction

Neighboring community Master Plans – Newbury & Merrimac are currently completed, obtain copies if possible
