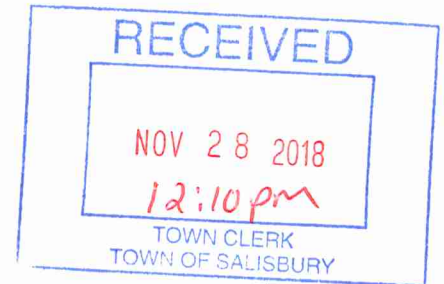

BOARD OF HEALTH AGENDA December 4, 2018

The following amendments would prohibit the sale of tobacco products (including vape products) to persons under the age of 21 in Salisbury. I have attached the Salisbury regulations as reference for your convenience.

1. In Section 1 "Definition" after Section 4.1.0202 add the following section:

4.1.021 TOBACCO AND/OR TOBACCO PRODUCT: Any product containing, made, or derived from tobacco or nicotine that is intended for human consumption, whether smoked, chewed, absorbed, dissolved, inhaled, snorted, sniffed, or ingested by any other means, including, but not limited to: cigarettes, cigars, little cigars, chewing tobacco, pipe tobacco, snuff, or electronic cigarettes, electronic cigars, electronic pipes, electronic hookah, or other similar products, regardless of nicotine content, that rely on vaporization or aerosolization. "Tobacco product" includes any component or part of a tobacco product. "Tobacco product" does not include any product that has been approved by the United States Food and Drug Administration either as a tobacco use cessation product or for other medical purposes and which is being marketed and sold or prescribed solely for the approved purpose.

2. Strike the title of Section 4 and substitute it with the following:

Tobacco Sales to Persons Under the Minimum Legal Sales Age Prohibited

3. Strike the first sentence of Section 4.4.002 and substitute it with the following:

No person shall sell tobacco products or permit tobacco products, as defined herein, to be sold to a person under the minimum legal sales age. Effective December 28, 2018, the minimum legal sales age in Salisbury is 21.

Also the two references to "minors" shall be stricken and substituted with the phrase "persons under the minimum legal sales age."

4. Section 4.4.004 "Employee Statement" shall strike all references to "18" and substitute them with "21." Also, regardless of whether the Board decides on raising the minimum legal sales age to 21, I highly recommend inserting in the second to last sentence of this section the following: "ID verification is required for any person under the age of 40."

5. Section 4.4.005 "Possession" shall delete reference to "eighteen (18)" and substitute it with "twenty-one 21."
6. Section 5 "Vending Machines." In Section 4.5.001 all references to "minors" shall be stricken and substituted with the phrase "persons under the minimum legal sales age."
7. A final section should be inserted making it clear that effective date of age 21 is December 28, 2018.
