

**WARRANT FOR THE ANNUAL FALL TOWN MEETING  
OCTOBER 26, 2020**

TO: Richard Dellaria, of the Salisbury Police Department

**GREETINGS:**

In the name of the Commonwealth, you are hereby required to notify and warn the inhabitants of the Town of Salisbury who are legally qualified to vote in Town affairs, to meet at the Salisbury Elementary School at 100 Lafayette Road in said town on Monday, October 26, 2020 at 7:00 PM, to then and there act on the Articles in this Warrant.

**ARTICLE ONE**

To see if the Town will vote to transfer the sum of \$100,000.00 from Free Cash to the Stabilization Fund; or to take any other action relative thereto.

ON PETITION OF THE TOWN MANAGER

**ARTICLE TWO**

To see if the Town will vote to transfer the sum of \$15,000.00 from Free Cash to FY2021 budget line item number 0101.0413.5240 (DPW – Purchase of Services – Building Repair and Maintenance) for the purpose of repairing and/or stabilizing the roof on the former Fire Station building located on 4<sup>th</sup> Street, including all incidental and related costs; or to take any other action relative thereto.

**ARTICLE THREE**

To see if the Town will vote to transfer the sum of \$9,800.00 from Free Cash to FY2021 budget line item number 0101.0123.5305 (Town Manager Purchase of Services– Consulting Fees) for the purpose of engaging an engineer to prepare a road layout and acceptance plan for Jak-Len Drive, including all incidental and related costs; or to take any other action relative there.

**ARTICLE FOUR**

To see if the Town will vote to transfer the sum of \$24,500.00 from Free Cash to FY2021 budget line item number 0101.0124.5275 (Central Services – Software Maintenance/Support) for the purpose of upgrading the software utilized by the Assessing Department, including all incidental and related costs; or to take any other action relative thereto.

#### **ARTICLE FIVE**

To see if the Town will vote to transfer the sum of \$4,400.00 from Free Cash to FY2021 budget line item number 0101.0241.5275 (Building Inspector – Software Maintenance/Support) for the purpose of providing improved integration capabilities for the Building Department's new software permitting system, including all incidental and related costs; or to take any other action relative thereto.

#### **ARTICLE SIX**

To see if the Town will vote to transfer the total sum of \$13,052.50 from Free Cash to FY2021 General Fund Budget line item number 0101.0123.5798 (Town Manager – Other) for the purpose of paying outstanding bills from previous fiscal years from the Pettengill House, Inc. in the amount of \$10,000.00 and Millennium Engineering, Inc. in the amount of \$3,052.50; or to take any other action relative thereto.

#### **ARTICLE SEVEN**

To see if the Town will vote to authorize the Board of Selectmen to lease/purchase and equip a new cruiser for the Police Department in accordance with the provisions of G.L. c. 44, §21C, and further, to transfer the sum of \$19,500.00 from Free Cash to FY2021 General Fund Budget line item number 0101.0210.5850 (Police Department – Capital Outlay – Vehicles) for the purpose of funding the first year cost of a three-year lease/purchase agreement, including all incidental and related costs; or to take any other action relative thereto.

#### **ARTICLE EIGHT**

To see if the Town will vote to transfer the sum of \$14,400.00 from Free Cash to FY2021 budget line item number 0101.0210.5375 (Police Department - Purchase of Services – Police K-9 Program Costs) for the purpose of funding the purchase of a new canine and related equipment and accessories for the Police Department, including all incidental and related costs; or to take any other action relative thereto.

#### **ARTICLE NINE**

To see if the Town will vote to transfer the sum of \$11,500.00 from Free Cash to FY2020 budget line item number 0101.0123.5305 (Town Manager -- Purchase of Services – Consulting Fees) for the purpose of funding the costs of an assessment center examination for the position of sergeant in the Police Department; or to take any other action relative thereto.

**ARTICLE TEN**

To see if the Town will vote to transfer the sum of \$200,000.00 from Free Cash to FY2021 budget line item number 0101.0413.5241 (DPW – Purchase of Services – Street Maintenance) for the purpose of paving various streets in town, including all incidental and related costs; or to take any other action relative thereto.  
ON PETITION OF THE TOWN MANAGER

**ARTICLE ELEVEN**

To see if the Town will vote to transfer the sum of \$18,000.00 from Free Cash to FY2021 budget line item number 0101.0434.5294 (DPW Landfill/Recycling Center – Purchase of Services – Hazardous Waste Day) for the purpose of conducting a household hazardous waste disposal day for Town residents; or to take any other action relative thereto.

**ARTICLE TWELVE**

To see if the Town will vote to authorize the Board of Selectmen to lease/purchase and equip a new dump truck for the Department of Public Works, for a term in excess of three years, in accordance with the provisions of G.L. c.44, §21C, and further, to transfer the sum of \$15,500.00 from Free Cash to FY2021 budget line item number 0101.0413.5850 (DPW – Capital Outlay – Vehicles) for the purpose of funding the first-year payment of a four-year lease/purchase agreement, including all incidental and related costs; or to take any other action relative thereto.

**ARTICLE THIRTEEN**

To see if the Town will vote to appropriate the sum of \$3,750.89 from the Transportation Infrastructure Receipts Reserved for Appropriation Fund for the purpose of funding a portion of the cost of purchasing a hot box for the Department of Public Works; or to take any other action relative thereto.

**ARTICLE FOURTEEN**

To see if the Town will vote to transfer the sum of \$10,000.00 from Free Cash to FY2021 budget line item number 0101.0434.5815 (DPW Recycling Center – Purchase of Services – Equipment) for the purpose of purchasing new security cameras for the Town’s drop-off recycling facility, including all incidental and related costs; or to take any other action relative thereto.

**ARTICLE FIFTEEN**

To see if the Town will vote to transfer the sum of \$55,000.00 from Free Cash to FY2021 budget line item number 0101.0413.5241 (DPW - Purchase of Services - Street Maintenance) for the purpose of making additional drainage improvements to Liberty Street, including all incidental and related costs; or to take any other action relative thereto.

**ARTICLE SIXTEEN**

To see if the Town will vote to transfer the sum of \$9,900.00 from Free Cash to FY2021 budget line item number 0101.0123.5305 (Town Manager -- Purchase of Services – Consulting Fees) for the purpose of engaging an engineer to prepare a road layout and acceptance plan for Liberty Street, including all incidental and related costs; or to take any other action relative there.

**ARTICLE SEVENTEEN**

To see if the Town will vote to transfer the sum of \$25,000.00 from Free Cash to FY2021 budget line item number 0101.0413.5241(DPW – Purchase of Services – Street Maintenance) for the purpose of funding a portion of the Driftway reconstruction project, including all incidental and related costs; or to take any other action relative thereto.

**ARTICLE EIGHTEEN**

To see if the Town will vote to transfer the sum of \$200,000.00 from Free Cash to the Compensated Absences Reserve Fund; or to take any other action relative thereto.

**ARTICLE NINETEEN**

To see if the Town will vote to transfer the sum of \$25,000.00 from Sewer Enterprise Fund Retained Earnings to the Compensated Absences Reserve Fund; or to take any other action relative thereto.

ON PETITION OF THE TOWN MANAGER

**ARTICLE TWENTY**

To see if the Town will vote to authorize the Board of Selectmen to acquire, by purchase, gift and/or eminent domain, a permanent easement for utility purposes in, on, and under a portion or portions of the parcel of land located at 3 Broadway and identified by the Assessors as Parcel 33-184, which easement area is approximately shown as “Parcel A” on a plan entitled “Plan of Land in Salisbury, MA Prepared For The

Town of Salisbury,” dated October 9, 2020, prepared by Millennium Engineering, Inc., a copy of which is in file in the office of the Town Clerk, as the same may be amended; or to take any other action relative thereto.

ON PETITION OF THE TOWN MANAGER

**ARTICLE TWENTY-ONE**

To see if the Town will vote to amend Chapter 209 of the General Bylaws by amending Article 1, Section 209-3 (Establishment of Zones) by inserting the following sentence at the end of said section as follows: “A copy of the official sewer service zone map for the Town shall be maintained by the Office of the Town Clerk”; and further to adopt a new sewer service zone, to be known as the “Lafayette Road/Main Street Sewer Service Zone,” as shown on a map on file with the Town Clerk’s office; or to take any other action relative thereto.

**ARTICLE TWENTY-TWO**

To see if the Town will vote to appropriate \$83,075.03 from the PEG Access and Cable Related special revenue fund to support the provision of public, education and governmental access cable television services. This amount represents 100% of Comcast’s payments to the Town for the fiscal year 2020 annual Cable-Related Equipment/Facilities Funding and the fourth quarter Franchise Fee payment for April - June 2020 per sections 6.3 and 7.2, respectively, of the Town’s Cable TV Renewal License contract; or to take any other action relative thereto.

**ARTICLE TWENTY-THREE**

To see if the Town will vote to transfer the sum of \$280.00 from Sewer Enterprise Fund Retained Earnings to FY2021 Sewer Enterprise Fund Budget line item number 6000.0440.5798 (Sewer - Other) for the purpose of paying an outstanding bill from Dependable Controls Services LLC from a previous fiscal year; or to take any other action relative thereto.

**ARTICLE TWENTY-FOUR**

To see if the Town will vote to transfer the sum of \$40,000.00 from Sewer Enterprise Fund Retained Earnings to FY2021 Sewer Enterprise Fund budget line item number 6000.0440.5830 (Sewer Enterprise Fund – Infrastructure), such funds to supplement an appropriation approved under Article 19 of the June 22, 2020 Special Town Meeting, for the purpose of replacing sewer manholes and upgrading the Town’s sewer line on Fowler Street; or to take any other action relative thereto.

**ARTICLE TWENTY-FIVE**

To see if the Town will vote to transfer the sum of \$553,675.00 from Sewer Enterprise Fund Retained Earnings to FY2021 Sewer Enterprise Fund Budget line item numbers 6000.0440.5910 (Long-Term Debt Principal) and 6000.0440.5915 (Long-Term Debt Interest) for the purpose of paying the first year debt service costs for Wastewater Treatment Facility and Lafayette Road Sewer Construction general obligation bonds issued September 10, 2020; or to take any other action relative thereto.

**ARTICLE TWENTY-SIX**

To see if the Town will vote to transfer the sum of \$130,139.00 from the Ring's Island Water Main Replacement special revenue fund to FY2021 Water Enterprise Fund Budget line item numbers 7000.0450.5910 (Long-Term Debt Principal) and 7000.0450.5915 (Long-Term Debt Interest) for the purpose of paying the first year debt service costs for Bridge Road Water Main general obligation bonds issued September 10, 2020; or to take any other action relative thereto.  
ON PETITION OF THE TOWN MANAGER

**ARTICLE TWENTY-SEVEN**

To see if the Town will vote to transfer the sum of \$29,680.00 from Water Enterprise Fund Retained Earnings to FY2021 Water Enterprise Fund Budget line item number 7000.0450.5320 (Purchase of Services -- Water System Operating & Maintenance Contract) for the purpose of funding increased contract costs associated with the merger of Rings Island Water District customers into the Town's water system; or to take any other action relative thereto.  
ON PETITION OF THE TOWN MANAGER

**ARTICLE TWENTY-EIGHT**

To see if the Town will vote to accept the provisions of MGL Chapter 59, §5, Clause 22G, whereby real estate that is the domicile of a person but is owned by a trustee, conservator or other fiduciary for the person's benefit would be eligible for exemption under Clause 22, 22A, 22B, 22C, 22D, 22E, or 22F if the person were the owner of the real estate, such adoption to be effective for Fiscal Year 2021; or to take any other action relative thereto.  
ON PETITION OF THE TOWN MANAGER

**ARTICLE TWENTY-NINE**

To see if the Town will vote to establish a bylaw by establishing a Resident Only Parking Program for the North End and South End of Salisbury Beach on all streets with the exception of any state-controlled streets or private ways. Any homeownership residents of Salisbury will be allowed to purchase up to two placards per unit at a cost of \$25 per placard. Placards must be clearly displayed in the vehicle parked in the

designated resident only parking areas. The placards will be distributed by a town employee designated by the Town Manager. Proof of home ownership must be presented at the time the placards are being purchased. Only cars with town issued placards will be allowed on the designated resident only streets. Police enforcement of this program will occur based on the availability of police officers and parking enforcement officials. The Resident Only Parking Program will be in effect from May 15<sup>th</sup> through Labor Day; or to take any other action relative thereto.  
ON PETITION OF JOHN HOUSIANITIS et al.

**ARTICLE THIRTY**

To take any other action that may be lawfully taken at this meeting.

And you are hereby directed to serve this Warrant by posting attested copies in at least ten (10) public places in Town over two consecutive Sundays before the time of said meeting.


