- Passing 3/8 100% minimum
- Passing No. 50, 22% maximum
- Passing No. 200, 1% maximum

In addition:

- Water content shall not exceed 5% of the weight
- No sand shall be stockpiled or hauled during rainy weather
- All sand delivered shall be spot checked by the Department of Public Works as it is delivered
- All deliveries will require computerized printed weight slips

Price quoted shall be by the ton delivered to the Department of Public Works Garage at 39 Lafayette Road. Sand shall be delivered within 72 hours of placement of order.
