March 7, 2017 Meeting Minutes

### **Old Business**

Appeal of Fine at 128 Railroad Ave - Daniel Belfiore

Jack summarizes the facts of the case:

October 2015 Mr. Belfiore was notified that he needed certificates of habitability for 126 & 128 Railroad Ave. Mr. Belfiore did not respond to this notification.

February 2016 Mr. Belfiore was brought into court magistrates hearing to determine probable cause for an issuance of a criminal complaint. Mr. Belfiore had one month to comply.

February 24, 2016 – March 26, 2016 two units were inspected at 128 Railroad Ave and a couple of the units at 126 Railroad Ave were inspected. Mr. Belfiore filed exemptions for 4, 5 and 6 at 128 Railroad Ave claiming that these units were occupied by a family member.

November 22, 2016 Camille Horvitz (tenant) filed a complaint that there was no heat in her unit. It was discovered at this time that Camille Horvitz is not related to Mr. Belfiore as indicated on the affidavit.

Mr. Belfiore and his contractor, Mr. Callahan, summarize the violations that have been addressed and resolved, but these violations were not related to the false information on the exemption affidavit.

Dan Richards asks Camille Horvitz to approach the podium. Dan Richards asks Camille how long she has lived at the property, if she is related to Mr. Belfiore and when she was first notified of eviction. She has lived at the property for 6 years, states that she is not related to Mr. Belfiore and that she wasn't notified of the eviction in October 2016 as Mr. Belfiore had stated.

Ron Laffely makes a motion to sustain the fine of \$26,500 in its entirety to be paid in 30 days. Denise Peterson seconds the motion. 4 in favor, 0 opposed. Motion carries unanimous.
