New Business

Seaside Brewfest 2017

Lisa D. reported that Neil was okay with holding the Brewfest on the boardwalk, and is being supported by the fire department. If there is no damage, all will be well. Neil's main concern was grease on the boardwalk. Ronalee reported that the final details will be ironed out at a subcommittee meeting.

Skate Park @ Partridge Brook Park

Ronalee reported that the subcommittee agreed to write another PARC grant, despite the odds not being in our favor. Ronalee stated that Lisa P. feels as though it is still worth it because it gets reviewed, and if the application is denied the Town can reapply next year. The funding would be \$600,000 total. The first \$200,000 would go towards engineering, and the rest would go towards the skate park/ skate street hockey rink. Lisa Pearson will bring blue prints to the next meeting. Ronalee also reported that for Phase II match money Freeman will talk to the Institution for Savings. Lisa P. also plans to approach Arakelian Foundation, Newburyport Five Cents Savings Bank, and the Tony Hawk foundation. The Lions Club is also working towards raising money for the handicapped park and tot lot.

Pickle ball

Ronalee stated that the senior center wanted a pickle ball court last year. It is the fastest growing sport. There was recently an article in the Daily News. Ronalee would like to see one of the tennis courts made into a pickle ball court. What are the next steps that need to be taken? Sean responded that the court could be painted and the cracks could be sealed. Then all that would remain would be line painting. Ronalee reported that according to the ambassador that she met with there would be enough room and she thinks the court would get more use. Lisa D. responded that she thinks the Commission is better off converting one court. Sean replied that he could reach out to the contractor that does Hamilton's courts, some people line themselves. The lines need to be precise. The Commission would need a net, balls, and paddles, although most people have their own paddles. The ambassador could help spread the word, or there could be set times for pickle ball.
