Case #17-01 66 Main St – Modify Special Permit for Drive Through

DP notified the Applicant that there are only 4 board members available this evening, a successful decision would require a 4-0 vote, do you wish to proceed?

Brian Levey, Attorney for Applicant – yes, we will proceed but I wish to get a feel of how the board is reacting and reserve the right to withdraw to another hearing.

DP – I cannot say how other board members might vote. BL said he was fine with that.

BL - Dan Berry from Bursaw, the Owner, is here. We are here to modify a special permit for the Fast Freddie's Convenience Store and Gas station on Main St.

BL - The building was designed with a drive thru which it still presently has. In 2004 the ZBA granted a permit to allow '*a drive thru that is owner operated but not subleased*'. Bursaw now wishes to lease to Burger King and we are here to seek clean-up of that zoning issue.

BL - The sight was built to handle a drive-thru. There are other retail drive thru's in the neighborhood, such as Dunkin Donuts across the street.

SV – The underlying zoning was changed to LMA in 2016 and I consider the property to be pre-existing, non-conforming. A restaurant is allowed by approval of the Planning Board. LT – Why was there a restriction?

SV – I have researched the limited record and no specific reason was noted.
